After contact with the eyes rinse thoroughly under running water with the eyelid wide open for min. 10 minutes with eye washing bottle, eye douche or running water (protect intact eye). 4.1.3 After INHALATION of vapours

4.2 Most important symptoms and effects, both acute and delayed

Rapid penetration and destruction of the skin. Especially in the heated form. Causes severe skin burns and eye damage.

4.3 Indication of any immediate medical attention and special treatment needed

CORROSIVE DAMAGE: After SKIN CONTACT rinse with water for a long time. Efforts to neutralise the substance can frequently make matters worse.
